

**Terms of exhibitory – recreational Event**  
**12th INTERNATIONAL TUNING TRUCK SHOW MASTER TRUCK**  
**Polska Nowa Wies near Opole, Poland, 22-23-24 July 2016**

**I. GENERAL PROVISIONS:**

The organizers of the Event (hereinafter referred to as "the Show") are:

- BRAVO Television Studio – the producer of „On the axle” TV program, based in Chroszczyna, 1 Nowowiejska Street,
- Driver Training Centre „Improvement of Driving Techniques „DELTA”
- Opole Aeroclub

(hereinafter referred to as "the organizers").

Regulations are issued by the exhibitory – recreational event organized under the name:

INTERNATIONAL TUNING TRUCK SHOW „MASTER TRUCK” which will be held on 22-23-24 July 2016 on Autodrome – Airfield in Polska Nowa Wies, Municipality Komprachcice near Opole, 46-070.

1. Regulations are directed to all persons who during the Show will stay in the area where the Show is carried out. Any person entering this area during the Show is obliged to comply with the provisions of these Regulations.

2. The Show is a recreation exhibition.

The purpose of the Regulations is to ensure the safety of Show by defining rules of behavior of people present at the Show and their use of the land on which the Show is carried out, as well as devices that are on it, and also to regulate the rights and obligations of the participants of the Show.

**II. THE RULES OF BEHAVIOUR IN SHOW'S AREA**

1. All persons present at the Show are obliged to:
  - a. The behavior in accordance with the rules of the Show and the applicable regulations, including the regulations on fire safety
  - b. to comply with the orders of the organizers and guard.
  - c. the use of facilities located in the Show's area for their intended purpose,
  - d. not going to areas that are not acceptable for viewers (service facilities)
  - e. notification protection service if disclosed risks to safety and public order,
  - f. to report any accidents and damage to protection service,
2. In case of an emergency one should immediately go toward the exits.
3. Detailed rules of conduct of participants in case of evacuation will be made public from the scene in the form of messages.

**III. ADMISSION INTO THE SHOW:**

1. The area of the Show will be open to the public on 22-23-24 July 2016. In the following hours:
  - 22.07.2016 r. - From 16:00 to 24:00.
  - 07.23.2016 r. - From 10:00 to 24:00.
  - 07.24.2016 r. - From 10:00 to 18:00.
2. The condition for admission to the Show is the participation in competition Master Truck of Public construed as the ability to vote in the Master Truck of the Public contest.
  - a. Participation in the contest Master Truck of the Public is available for persons over 12 years of age on presentation of the Voting Card for the prettiest truck in the Contest Master Truck of the Public. Other persons will enter the territory of the Show under adult supervision.
  - b. The cards are available at the entrance to the Show.
  - c. The card price is 15 PLN (Polish Zlotys).
  - d. Each buyer has the right to purchase any amount of Voting Cards.
  - e. In order to be able to move freely around the grounds of the Show, at the entrance of every adult person it is established identification wristband

entitling to stay in the eligible locations throughout the Show.

f. Wristband of color chosen by the organizers, is valid only for the day of its purchasing and to maintain law and order at the Show and improve the organization of the Show above procedure is repeated every day of the Show.

f. Entrance to Show the next day it will be possible with the presentation of new voting card with a valid coupon and receipt of a new wristband effective that day.

g. In order to prevent re-use, at the entrance of the Show service distracts coupon from the voting card

3. Show organizers may refuse admission to the Show and stay there for the people who are:

- a. being under the visible influence of alcohol, narcotics, psychotropic substances or other similar substances,
- b. carrying weapons or other dangerous items, materials, goods, beverages, drugs or substances considered dangerous.
- c. behaving aggressively, provocatively or otherwise posing a threat to security or order of Show.
- d. those who in previous editions of the Show behaved in the manner specified in subsections: a. b. c. above

Rating objects as hazardous is a matter of the Security Service.

4. Except the hours indicated in point. II. 1., it is prohibited to stay at the Showground to unauthorized persons.

5. There is a campsite organized on the Showground which one can use on the basis of the provisions included in a separate rules and regulations, which are publicly accessible.

6. It is forbidden to bring and possess in the Show weapons or other dangerous objects, explosives, pyrotechnic articles, fire hazard materials, alcoholic beverages, narcotics or psychotropic substances.

7. It can be ordered forfeiture of the items listed in paragraph 6, even not constitute property of the perpetrator.

8. It is forbidden to enter the premises of the Show for people with a dog without a muzzle. Dog's guardian should have a bag for feces. In the event that Show's area has become contaminated by animal, dog's guardian must immediately clean it up.

7. It can be ordered forfeiture of the items listed in paragraph 6, even not constitute property of the perpetrator.

8. It is forbidden to enter the premises of the Show for people with a dog without a muzzle. Dog's guardian should have a bag for feces. In the event that Show's area has become contaminated by animal, dog's guardian must immediately clean it up.

**IV. COMPETITIONS AND VOTING CARDS:**

1. Any person present at the Show have the right to participate in all competitions carried out during it, provided that it meets the conditions defined in each case by conducting the contest.

2. In order to participate in the Master Truck of the Public contest it is necessary to throw a properly completed voting card into the marked ballot box, which is situated in the designated area near the Shows main square.

a. Every person has the right to purchase an unlimited number of voting cards

b. There will be drawn prizes among voters in the contest Master Truck of the Public.

c. Each voter consents to the processing of their personal data by the producer of "On the Axle" TV program and to publish their names and places of residence in the media related to the program, ie. in TV, on the website of the program and Show, and to send them a prize sponsored by the organizers

d. The organizers reserves the right to not send the prize to drawn people who incorrectly filled voting card

3. Vehicles which formally entered the list of participants take part in the election of the most beautiful truck of Master Truck Show.

a. Vehicles have the opportunity to participate in competitions in the main categories (under condition that they meet the technical and formal requirements): Master Truck of Public, Master Truck (Best of Show), Master Truck of Poland, Master

Truck of Light, Master Truck of Interior, Master Truck of Sound, Master Truck Special Vehicle and so on.

b. Vehicles may also be highlighted in subcategories not related to the main categories (eg. vans or Oldsmobile) by the organizers and by companies and institutions participating in the Show, provided that it has been included in the scenario of Show.

c. The winners in all categories except the Master Truck of Public selects a group of judges selected by the organizers of the owners of customized vehicles, representatives of companies and organizations taking part in the Show, and independent experts.

d. The organizers have the right to put on the list of participants Show vehicles that have not been notified formally, if in previous years they took first place in one of the main categories of Show's competition.

4. During the Show takes place accompanying event the Master Mini Truck, which brings together modellers, on the principles contained in separate regulations.

5. During the Show there are announced results of Master Truck of the Year award, ie. the best commercial truck of the year chosen by automotive journalists of Republic of Poland, on the principles contained in separate regulations.

**V. REGISTRATION OF PARTICIPANTS:**

1. Truck owners who wish to participate in the Master Truck Show submit their participation in the following way:

a. They should fill in the form located in the „Registration for the Show” bookmark available on the Master Truck's website ([www.mastertruck.pl](http://www.mastertruck.pl)) and join at least one picture of the vehicle.

b. in case of problems with completing the form, they should send an e-mail on [mastertruck@mastertruck.pl](mailto:mastertruck@mastertruck.pl) with the following information:

- 1) make, model, registration number
- 2) year of manufacture, type of vehicle (tractor, set, tow truck, etc.)
- 3) whether the vehicle has an interior tuning - if so - briefly describe
- 4) whether the vehicle has a car audio tuning - as above.

5) the type of additional lighting inside and outside

6) details of the company (name, owner's name, address)

7) the direct contact phone number to the owner or driver

8) one or two photos of the vehicle not exceeding 1MB

c. the forms will be accepted by July 15, 2016 or depending on free spaces.

d. after the above stated date the vehicles will be accepted directly at the Show depending on free spaces.

e. The organizer informs each participant if he was accepted in the participants list via e-mail to the address indicated on the form.

2. The organizers reserves the right to use truck photos submitted by participants for promotional purposes. The responsibility for the pictures which are subject to third party rights will be incurred by the participant who sent them.

3. Trucks submission and non-commercial participation in the Show is free of charge.

4. Truck submission and not reaching the Show for technical reasons do not involve any consequences to participant.

5. On board the truck may be a double crew. If the vehicle tuning requires assistance in preparing the truck for the Show - washing, polishing - organizers allow free participation additional 2 persons team. Each additional person (over 4 person team) is required to purchase voting cards.

7. If the trailer or semi-trailer does not constitute a set

of tuning - is not entitled to enter the Show and must remain outside the Showground. The organizer does not provide parking for trailers.

8. The organizer has the right to refuse registration and participation for the Show to participants whose vehicles have not been tuned optically or whose application has not been transferred correctly (eg. the lack of required information) or who violates or have ever broken the rules of the Show (eg. conducting unauthorized commercial activities or the use of sound signals), or for other reasons - according freely to the own will of the Show's Organizer.

9. Organizer assigns exhibition space for participant, for which the participant takes full responsibility, particularly for law and order and the safety of persons within that space.

**VI. ORGANIZATIONAL AND ORDER RULES IN THE SHOW:**

1. The organizers ensures the safety of the persons present at the Show and order during the Show by e.g.:

a. Security Service, medical service, fire brigade and information services distinguished by clothing elements;

b. access to medical aid and sanitary facilities;

2. Co-organizers and contractors must have valid insurance policy.

3. Co-organizers, contractors and their subcontractors and participants are responsible for their subcontractors.

4. Participants of the Show, and all other persons who are in the Show are obliged to follow the instructions of Security Service. Refusal to comply with these commands may result solely because of their contradiction with the general applicable provisions of law. Minors participate in the Show on the sole responsibility of persons who take care of them.

5. Show Participants and any other persons who are in the Show are obliged to behave in a way that does not endanger the safety of other persons present at the Show, and in particular comply with the provisions of the Regulations. It is prohibited to carry out these activities under the threat of removal from the Showground:

a. it is prohibited to conduct in the Show any promotional, commercial or other gainful employment without the authorization of the Organizer.

b. it is prohibited to use in the Show open flames in any form, and above all: firing campfires, grills, gas burners, etc. prohibition does not apply to the gastronomic stands authorized by the organizers. Those who do not comply with this point will be immediately removed from the Showground.

c. it is prohibited to bring in and consume in the Show alcoholic beverages purchased outside gastronomic stands authorized by organizers

d. It is forbidden to destroy the signs and information boards, advertising media, equipment located in the Show, including vehicles of participants and organizers, etc.

e. It is prohibited to enter the Master Truck Participants vehicles' interiors and to hung and the like behavior in relation to them without the prior express consent of the vehicles owners.

f. it is prohibited to use sound signals that are installed on or inside the vehicles at the airport. Responsible for compliance with this provision is a participant, who arrived at the event with the vehicle. In case of violation of this prohibition, the participant agrees to render the electro-pneumatic system in his vehicle by the Security Service and to remove from the event at the expense of the participant. Violation of the ban is tantamount to disqualification from Master Truck competitions.

g. It is forbidden to move around the Showground in motor vehicles without Organizer authorization.

h. Prohibited are unauthorized flights of all kinds of

units, such as drones, flying models, kites ect .. as well as installing and spreading upward at the airport facilities in excess of 8 m high, such as cranes, HDS, increases ect. Such flights and devices can be carried out and fold-out only with the consent of the Organizer and in agreement with the administrator of Airports Aero Club of Opole.

i. it is prohibited to organize auctions, loud music playing, performances and other forms of playground including contests and auctions without the authorization of the organizers.

j. Participants are required to use the sanitary facilities only for their intended purpose.

5. The organizers reserves the exclusive right to use and distribute among the people entering the Show all the elements of identification such as badges, cards, ID cards, identification wristbands, holograms, ski passes, leashes and other personal controllers.

a. The organizers reserves the right to confiscate unauthorized identification elements those who use them.

b. People who use the unauthorized identification elements will be urged by Security Service to absolute leave the premises of the Show.

6. The organizers are entitled to record course of Show, in particular the behavior of persons, by means of image and sound recording devices. Entrance to the Show is tantamount to consent to record persons image and use it in all fields of use.

7. The materials collected during monitoring and recording the Show, which may provide evidence for the initiation of criminal proceedings or proceedings in misdemeanor cases or evidence that may be relevant to such legal proceedings, the organizers shall immediately transmit the District Prosecutor competent for the location of the Show or competent territorially to the district Police commander, if necessary proposing the initiation of criminal proceedings or for punishment, unless he notifies the crime or to submit a request for punishment in cases of misconduct.

8. Security Service possessing identifiers placed in visible places is entitled to:

a. control ID cards in order to establish persons identity,

b. control identification elements of persons present in the Show

c. browse the contents of persons luggage and clothing, in case of suspicion that these persons bring in or possess the items referred to in point. 3 b par. II hereof regulations,

d. issue instructions to persons disturbing public order or behaving contrary to the rules Show, and in case of failure of these commands - call them to leave the Show;

e. use of physical force in the form of incapacitating holds and similar techniques of defense in case of emergency goods entrusted the protection or repel a member of the Security Service or any other person, under the terms of Art. 38 of the Act of 22 August 1997. On the protection of persons and property (Dz. U. No 114, item. 740, as amended. D.)

f. recognition, in order to immediately transfer the Police, persons posing a direct threat to human life or health, as well as protected property.

g. dismantling the installation of audio signals in offenders' vehicles Section IV, Section 5 paragraph f of these regulations.

9. in case of founding weapons or other dangerous objects, alcoholic beverages, explosives, pyrotechnics and fire hazardous materials, narcotics, drugs or psychotropics in the inspected luggage or clothing of persons entering the Show, member of the Security Service shall arrest these persons and passes them instantly to the Police along with the founded items.

10. The Show organizers are not responsible for possible damage to the health and lives of people participating in competitions carried out during the

Show. People involved in those competitions and any other actions they take at the Show, they do so at their own risk. The Show organizers are not responsible for possible damage to the health and lives of people due to the violation of the principles of the Rules of Procedure.

11. The Show's organizer does not accept any responsibility for items left at the Show, including the vehicles located within the Show.

**VII. PARTICIPANTS' RIGHTS AND OBLIGATIONS:**

1. The organizers reserves the right to determine and change the course of Show with legitimate reasons, eg. the appeal of arrival by the artist, Force Majeure, etc., and also the right to determine and revision of the Show's program in terms of artistic and time.

2. Show's Participants are obliged to comply with the generally applicable provisions of:

a. fire protection

b. order

c. traffic

3. Participants Show are entitled to use:

a. all sites and facilities available to the public

b. the medical care in case of sudden illness or accident

c. the help of Show organizers and law enforcement agencies in unexpected situations.

4. The organizers has the right to refuse to participate in the Master Truck contest to owners of vehicles that have not been formally submitted to the Show and who failed to show up at the Show before 10:00 am on Friday, July 22, 2016 r.

**VIII. COMPLAINTS:**

1. Any complaints can be submitted in writing no later than 7 days from the end of the following Show to organizers's address:

2. The organizers recognizes the complaints submitted in accordance with paragraph. 8 within 21 days from the date of notification to the Organizer by registered mail. The complaints must have proof of shipment registered letter.

3. The condition of redress is the exhaustion of the complaint procedure, referred to in this section of the Regulations.

**IX. FINAL PROVISIONS:**

1. All rights to the name, logo, graphic materials, audio and television Show are reserved for the organizers.

2. The organizer does not accept responsibility for the consequences of force majeure. Force majeure is beyond an Show's organizers control and causes that the fulfillment of the obligations is impossible or that it can be considered impossible due to the present circumstances. Force Majeure are in particular: weather conditions, failure or disruption of devices that provide electricity, heat, light, act of war or act of state or government in the formulation of policies, laws and regulations affecting the performance of obligations.

3. These Regulations are available:

a. on the website of Show, ie. [www.mastertruck.pl](http://www.mastertruck.pl)

b. in the office of the organizers in the Show.

4. Amendments to the Regulations require reporting to the message as described in point. 3 pairs VIII of the Rules of Procedure.

5. Security Service can issue their own instructions and fire safety in accordance with applicable law.
